Specific Responsibilities

"The Second Vice President serves on the Board for 4 years, in progressive positions. The Second Vice President chairs the Fellowship Committee, whose deadline is beginning of February each year. The Second Vice President also assists the President by performing duties assigned and, when necessary, assumes the duties and

responsibilities of the President. The VPs share with the President and the Executive Director responsibility for the annual convention. With the assistance of the Vice Presidents, and the advice of the Board, the President and the Executive Director plan the annual convention. The Second Vice President is also responsible for negotiating an agreement with a higher education hosting institution for the NeMLA conference that will take place on the year they will be the acting President. A new Second Vice President is elected every year to the NeMLA Board.

The Directors represent the interests of the membership as a whole as well as of their particular Area constituency. They oversee the convention program for their particular Area, including the suggestion of Board-sponsored sessions, and work to help the Executive find speakers and other programs. In addition to the convention program committee, they may also be requested to serve on the Board's various other committees. Area Director nominations are staggered. Nominations are due by June 15. 2. CALL FOR PAPERS AMBITOS FEMINISTAS JOURNAL (VOLUME 6-FALL 2016)

The editors of *Ámbitos Feministas*, a multidisciplinary journal of criticism pertinent to current feminist issues in Spanish, Spanish-American, Luso-Brazilian, Afro-Latin American, Caribbean, U.S. Hispanic and Latino Studies, invite unpublished critical essays in English, Spanish, and Portuguese on literature, film, art, plastic arts, music, gender studies, history, etc., relating to contemporary Hispanic/Luso/Latina women writers and artists. Original unpublished creative work (short stories, poetry) is also encouraged. The accepted papers will appear in the next annual fall volume.

EDITORIAL GUIDELINES FOR SUBMISSIONS

Manuscripts should be between 17-25 double-spaced pages in length, including all notes, as well as the Works Cited. They should be formatted using Times New Roman Size 12 and 1-inch margins. For review purposes, originals should contain no reference to the author. Include a one page cover letter with author's information: name, rank, academic affiliation, email, postal address, essay's title, and a brief bio (8-10 lines) with latest publications. Essays need to conform to the most recent versions of the MLA Style Manual and Guide for Scholarly Publishing and the MLA Handbook for Writers of Research Papers. The

endnotes will be numerically superscripted in the text and the numbers referenced in the endnotes section. Automatically inserted endnotes should be converted to normal text in the final document.

A current membership to the Feministas Unidas, Inc. coalition (<http://feministas-unidas.org>) is required of all authors at the time of submission and must be kept until the end of the process.

SUBMISSION OF ORIGINALS

While we accept submissions at any time, in order to be considered for the Fall 2016 Issue, originals should arrive to our editorial office by February 29th, 2016. Submit original and cover letter as Word attachments to carmen.urioste@asu.edu

Feministas Unidas call for papers:

Hispanic/Latino Postfeminist biopics, media representations, and adaptations (Spanish, English, Portuguese)

This panel includes interdisciplinary approaches to Hispanic/Latino performative subjects in a variety of literary, cultural, and multimedia representations. Alternative cultural readings informed by life

writing theory, gender and sexualities, media and cinema studies, and/or popular culture studies, among others will provide the framework to consume alternative biopics. Media representations and literary and/or cultural adaptations include fiction and non-fiction biopics, biographical comics, docudramas, auto/biographical video-textures, photographic portraits, digital archives, corporeal markers as signatures, drawings or sketches, architectural sites, decorative arts as biographical mappings, among other non-canonical biographical narratives. Films, documentaries, graphic biographies, visual journals, animation, and/or cultural artifacts constructing a non-canonical biopic will be also considered.

4. Call for Papers: Fourth Annual Asians in the Americas (AIA) Symposium November 6-7, 2015, La Salle University, Philadelphia, PA

The Asians in the Americas symposium started in 2012 at Southeast Missouri State University as an answer and partial solution to the complete absence of any meaningful discussion of the many aspects of what it means to be Asian in the Americas in the forums that already existed. The scholars wanted to remove the topics from their status of being historical "footnotes." The symposium was the desired format because it combined scholarly research with the opportunity for in-depth conversation. The goal of the symposium that year, and each year since at Pepperdine and Rutgers, has been to expand the conversation, to cross borders and boundaries, both real and imaginary, to compare and contrast, but always with the idea that a unified study that linked the Americas and incorporated Asian in the greatest sense of the word would bring to the forefront the complexities of identity, citizenry, and Nation in discussions by and about people of Asian descent living in the Americas.

The symposium organizers are seeking proposals for panels and papers that engage the topic of what is or what it means to be Asian (from East Asia to West Asia) in the Americas. The AIA symposium strives to be interdisciplinary in nature and welcomes contributions from all fields including, the humanities, social sciences, and business. Papers and panels that cross disciplines are encouraged. Some suggested topics for our 2015 symposium include:

- 1) Theoretical frameworks and methodologies for studying the relations, contact zones, and spaces between Asia and Latin America.
- 2) The connections or disconnections between cultural politics and socioeconomic politics in discussions of Asian and Latin American relations.
- 3) The politics of mapping in spatial constructions of "Asia," "Latin America," "Transpacific" and/or "the global."
- 4) Questions of global imaginaries and transnational trajectories in drawing relations between Asia and Latin America, such as a revisiting of the Cold War, neoliberalism, global migration and World Systems Theory.
- 5) The politics of academic disciplines, the academic industrial complex, and knowledge production and their influence and/or manifestations in the study of Asia-Latin America.
- 6) The impact of popular culture trends such as K-Pop.

5. Monográfico 452ºF #14. Pensar el afecto desde la cultura y el arte

La noción de afecto —que guarda relación con conceptos tan diversos como las pasiones, los estados de ánimo, las sensaciones, los sentimientos y las emociones— ha sido un tema recurrente en la historia de la filosofía. Recientemente, asistimos a una creciente proliferación de trabajos académicos sobre el papel del afecto en los estudios sobre la cultura —especialmente en la línea de Spinoza, retomada por Gilles Deleuze en su conceptualización del afecto como capacidad corporal de afectar y ser afectado—, que evidencian lo que Patricia Clough identifica como «giro afectivo» en el campo de las humanidades y las ciencias sociales. Los estudios de Brian Massumi, Teresa Brennan, Jasbir Puar, Sara Ahmed, Michael Hardt y Lauren Berlant han contribuido a entender cómo la afectividad impregna el tejido de lo social, participando en la normalización y naturalización de las relaciones de poder, al mismo tiempo que conlleva un fuerte potencial para desarticularlas. A día 31 de enero de 2015, se abre la convocatoria para la recepción de los artículos del decimocuarto número de 452ºF. Revista de Teoría de la Literatura y Literatura Comparada, que se publicará el 31 de enero de 2016. Esta convocatoria está abierta y dirigida a todos aquellos que deseen participar y tengan los estudios mínimos de licenciatura.

Las bases que a continuación se exponen y que regulan la recepción y publicación de los distintos trabajos quedan sujetas a lo expuesto en el Sistema de arbitraje, el Manual de estilo y el Aviso legal. Todos ellos pueden consultarse en el área de Procedimientos de la [página web](#).

- El plazo de entrega de los artículos termina el 31 de julio de 2015 , siendo descartados los que sean recibidos con posterioridad a esta fecha.
- Es requisito indispensable para entrar en el proceso de evaluación que los artículos respeten las normas del [manual de estilo](#).
- El número de artículos previstos para esta decimocuarta publicación es de 8 a 12. Los artículos se inscribirán, según su temática, en la parte de la revista que le corresponda (monográfico o miscelánea).
- La parte monográfica queda limitada a la publicación de 4 a 8 artículos y, en este decimocuarto número, pretende reunir un cuerpo de trabajos que versen sobre el tema «Pensar el afecto desde la cultura y el arte». Un listado no exhaustivo de posibles temas es el siguiente:
 - a) Afecto vs. emoción, sentimiento, sensación. Acercamientos teóricos, epistemológicos y metodológicos.
 - b) Historia del afecto, historia afectada.
 - c) Afecto y prácticas de lectura.

- d) Afecto y estética. Hapticidad, sensación, recepción corporeizada.
- e) El afecto en el tiempo y el espacio. Geografías y temporalidades alternativas.
- f) Afecto y estudios de la materialidad. *Thing theory*, materialismo en la teoría feminista, materialismo queer.
- g) Afectos poshumanos, impersonales, animales.
- h) Políticas del afecto. Normatividades y disidencias afectivas.
- i) Utopías afectivas y afectos regresivos (*feeling backward*): amor, felicidad, depresión, vergüenza, fracaso, melancolía.

- El resto de los textos constituirán la miscelánea y, rigiéndose por los límites de la teoría de la literatura y la literatura comparada, la elección del tema y el planteamiento son libres.
- El envío de originales se realizará a través de OPEN JOURNAL SYSTEMS (OJS). Para poder realizar envíos a través de esta plataforma será necesario registrarse como AUTOR siguiendo este [enlace](#) (En caso de dudas, contacte con nosotros en redaccion@452f.com.

Convocatoria reseñas

Se abre asimismo una convocatoria de reseñas críticas que serán publicadas en un apartado de la revista dedicado a las novedades editoriales.

- Las reseñas deben ser originales y no haber sido publicadas con anterioridad.
- Los libros reseñados deben ser de teoría literaria, crítica literaria y/o literatura comparada.
- Los libros reseñados deberán tener fecha de publicación del año en curso o de los dos anteriores. Se valorarán también reseñas de primeras traducciones o de reediciones significativas para el área de conocimiento, siempre que la fecha de su publicación siga los parámetros expuestos.
- El formato y el sistema de notas, citas y referencias bibliográficas deben seguir los mismos criterios que los artículos, según el Manual de estilo de la revista.
- Las reseñas deberán tener un título, la referencia bibliográfica del libro reseñado y su número de páginas. No deben tener resumen ni palabras clave.
- La extensión de las reseñas no podrá exceder las 1500 palabras.

6. Call for Papers: Spring 2017 Special Issue of Ecozon@ on Iberian, Latin American, and Lusophone African Ecocriticism

Guest editors: Luis I. Prádanos (Miami University) and Mark Anderson (University of Georgia)

Over the last few years, a body of transatlantic ecocriticism has emerged, engaging with cultural production from both sides of the Atlantic Ocean to study literary and other discourses on ecological issues in a comparative context. The circulation of animal and plant species, capital, commodities, development and land management practices, forms of activism and resistance, and other phenomena affecting and

transforming local environments have been examined. Until very recently, however, this transatlantic ecocriticism has been synonymous with North-North (that is North American and Northern European) approaches to the representation of environment and ecological discourse. The incorporation of perspectives emerging from other transatlantic circuits has the potential to enhance significantly the ecocritical debate. Individual activists, artists, and scholars from the Iberian Peninsula, Latin America, and Lusophone Africa have begun to engage in intercontinental collaboration and dialogue on issues related to ecocriticism, but there is as yet no collection of articles or monograph devoted to this phenomenon.

We invite submissions for a special issue of *Ecozon@* dealing with transatlantic ecocriticism as it relates to the following or related topics:

- Iberian, Latin American, and Lusophone African ecocritical approaches and how these approaches can redefine, rethink, challenge, and contribute to transnational ecocriticism
- Influences, commonalities, and alliances between Iberian, Latin American, and Lusophone African eco-artists, ecocritical thought, and socioenvironmental movements
- Iberian, Latin American, and Lusophone African cultural responses to ongoing social, financial, and ecological crises
- Cultural responses to the social and ecological degradation provoked by neoliberal globalization in Iberia, Latin America, and Lusophone Africa (15-M, urban gardening, indigenous movements and Living Well, pro-common initiatives, Vía Campesina)
- The cultural expressions of post-growth paradigms articulated from these regions (degrowth, ecological economics, postdevelopment, post-extractivism, indigenous epistemologies, postcolonial environmentalism)

Manuscripts of 6000-8000 words should be submitted via the journal platform no later than July 15, 2016. Authors must comply with the guidelines Universidad de Alcalá | EASLCE & GIECO - Instituto Franklin - 2015 indicated on the platform, including the title, abstracts, and keywords (in the language of the article, English, and Spanish). MLA style should be used for citations. Permission must be obtained for any images used, and the images should be included in the text. Manuscripts will be accepted in English, Spanish, and exceptionally for this issue Portuguese. Although it is not essential, we would encourage potential authors to make prior contact with the editors through the submission of an abstract (approximately 500 words).
